ARTICLES OF INCORPORATION
OF
DR. JOSE P. RIZAL BRIDGE AND PARK PRESERVATION SOCIETY

KNOW ALL MEN BY THESE PRESENTS:

We the undersigned persons, acting as the Incorporators of a Corporation, have this day voluntarily associated ourselves together for the purpose of forming a non-profit organization under the provisions of the State of Washington Non-Profit Corporation Act (Revised Code of Washington, Title 24.03), and adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the Corporation shall be the "DR. JOSE P. RIZAL BRIDGE AND PARK PRESERVATION SOCIETY".

ARTICLE TWO

This Corporation shall be in perpetuity, or shall exist until such time when its Board of Directors shall dissolve the same, pursuant to existing law.

In the event of such dissolution, the vote of a majority of the Board of Directors is required. The same Board shall also designate one or more Trustees on behalf of the Corporation, and shall liquidate its assets in accordance with law.

In liquidating said assets, it must be treated as assets that are solely dedicated to an exempt purpose and must only be distributed for an exempt purpose, or to the Federal, State or Local Government for a public purpose.

Upon the dissolution of the Corporation, the Board of Trustees shall, after paying the liabilities of the Corporation, dispose of all assets of the Corporation exclusively for the purpose of the Corporation in such manner, or to such organization(s) organized and/or operated exclusively for charitable, educational, religious, recreational or scientific purposes as shall, at the time, qualify as an exempt organization(s) under Section 502(c)(3) of the Internal Revenue Code of 1954, (or the corresponding provisions of any and all future United States Internal Revenue Law), as the Board of Directors, through its designated Trustees shall determine (as amended, February 15, 1974).

ARTICLE THREE

This Corporation is organized exclusively for charitable, educational and recreational purposes, most specially the following:

To initiate and coordinate with the City of Seattle and other concerned agency or agencies to expand, preserve and develop the Dr. Jose P. Rizal Bridge & Park recreational facilities for the safety and enjoyment of the residents of the City of Seattle and the State of Washington.

Article Three: (continued) Articles of Incorporation

To venture on socio-civic activities which may tend to expound the precious and beautiful heritage of the Filipino people and their ancestry, with the works and ideals of Dr. Jose P. Rizal as the guiding light; and,

To do and perform such other activities and/or responsibilities aimed at the preservation, enhancement and realization of its goals and objectives.

Notwithstanding any other provision of these Articles, the Corporation shall not carry any other activity or activities not permitted to be carried on by a corporation exempt from Federal Income Taxation under Section 501(c)(3) of the Internal Revenue Code of 1954 (or corresponding provision of any further United States Internal Revenue Law).

ARTICLE FOUR

The asset(s) to be devoted for the maintenance and/or improvement of the Bridge, Park and the Corporation is such as may, from time to time, be received from contribution(s), donations and/or endowment(s) from private or public agencies, organizations or individuals, and such property or properties or money as may, from time to time, be received or acquired by deed, grant, device, bequest or gift. Also such money as shall be earned from the activities and facilities of the Corporation, if done in accordance with law.

That, no part of the net earnings of the Corporation shall insure to the benefit of, or be distributed or distributable to, its members, trustees, officers, or other private persons, except that, the Corporation shall be authorized and empowered to pay reasonable compensation(s) to services rendered and to make payments and distributions in furtherance of the purposes set forth in the goals and objectives of the Corporation or the purpose of its organization (as amended, July 18, 1974).

ARTICLE FIVE

Membership of the Corporation shall constitute people of all ages, regardless of nationality, race, religion, creed, and sex, directly affected and/or concerned with and by the Corporation's goals and objectives.

ARTICLE SIX

The address or the initial registered office of the Corporation shall be at 5725 N.E. 62nd Street, City of Seattle, County of King, Washington 98115. The name of the registered agent of the Corporation at such address shall be the current President or Chairman, Mr. E. V. "Vic" Bacho, until otherwise designated by the Board of Directors.

ARTICLE SEVEN

The governing body of the Corporation shall be the Board of Directors, who shall also be known as the Policy-Making Body of the Corporation, whose composition shall not be more than eleven (11) persons of good moral character and standing in the community.
